Affidavit of Diligent Search and Inquiry

Before me, the undersigned authority, this day personally appeared, XXXXX, of Pro Legal Serve LLC, who upon being first duly sworn, upon his oath, deposes and says:

Affiant is the XXXX of Pro Legal Serve LLC and an agent for Plaintiff. He is a State of Florida licensed private investigator (License No. XXXXX) and a certified process server with the 15th Judicial Circuit for Palm Beach County, Florida. He states he has made due and diligent search and inquiry to discover the name and residence of the subject person by performing each of the following acts set forth, as particularly as is known to Affiant, below.

After diligent search and inquiry by Affiant, the residence of the subject person is unknown to the Affiant. Defendant is over the age of 18 (eighteen) years.

Military manpower search conducted through the Department of Defense Manpower Data Center (SCRA 5.29), results as of 08/20/2026, Certificate ID xxxxxxxxxxx, shows no record of subject being on active duty, no record of subject having left active duty within 367 days of the status

date, and no record of notification of a future call-up to active duty. A true and correct copy is attached as Exhibit "E".

No current employer located.

N. Additional Efforts Made to Locate Defendant Are as Follows:

1. Inquiry of neighbors and occupants at known addresses.

On 12/20/2025 at 2:51 pm, at xxxxxxxxx, the process server spoke with the current homeowner, Arthur Resident, who stated that he purchased the home in 2017, that he has received mail addressed to the subject, and that he believes the subject was a previous resident.

On 01/26/2026 at 7:04 pm, at xxxxxxx, the process server spoke with the current resident, who advised that there is no Jane Person residing at that address. On 02/03/2026 at 2:46 pm, the process server was advised by leasing management for the complex that the subject moved out approximately one year prior and left no forwarding address on file.

On 08/10/2026 at 1:58 pm, at xxxxx, the process server spoke with the subject's brother, Jack Person, who stated that the subject is not in New York and lives in Florida.

2. Phone:

Contact was attempted at (xxx) xxx-xxxx. The call went to voicemail, and the voicemail greeting does not identify to whom the number belongs.

3. Relative Search:

Possible first-degree relatives identified in the database search include: John Person (age 50), Jack Person (age 27), As set forth above, a process server made contact with the subject's brother, who advised that the subject is not in New Jersey and lives in Florida, but did not provide a current address.

4. Unknown Spouse Search:

During our investigation, we were unable to verify if our subject has a current spouse. No spouse was identified among the possible relatives.

O. Addresses Attempted by Process Server:

1. On December 20, 2025 at 2:51 pm, a process server attempted service on Jane Person at xxxxx. The current homeowner advised that he purchased the home in 2017 and that the subject was believed to be a previous resident. The matter was returned non-served, a true and correct copy of which is attached as Exhibit "A".

2. On January 9, 2026 at 11:47 am, a process server attempted to service on Jane Person at xxxxxx, the business location of co-defendant. The coordinator advised that the subject is not an

employee and that there is no record of the subject ever having been one. The matter was returned non-served, a true and correct copy of which is attached as Exhibit “B”.

3. On January 26, 2026 at 7:04 pm, and again on February 3, 2026 at 2:46 pm, a process server attempted service on Jane Person at xxxxxxxx. Attempts were made on different days of the week and at different times of the day, including the afternoon and evening. On the first attempt, the current resident advised that the subject does not reside at that address. On the second attempt, leasing management advised that the subject moved out approximately one year prior with no forwarding address. The matter was returned non-served, a true and correct copy of which is attached as Exhibit “C”.

4. On August 10, 2026 at 1:58 pm, a process server attempted to service on Jane Person at xxxxxxxx. The subject’s brother advised that the subject is not in New Jersey and lives in Florida. The matter was returned non-served, a true and correct copy of which is attached as Exhibit “D”.
